Enclosed are documents that summarize revisions for the *CDT 2023 Dental Procedure Codes* manual and the *HDS Procedure Code Guidelines (PCG)* that take effect on January 1, 2023. These revisions incorporate code changes in CDT 2023 and clarification of the PCG to facilitate better understanding of the procedure codes, clinical criteria, and policies.

Notable changes for CDT 2023 and the 2023 Procedure Code Guidelines include:

- 22 new procedure codes
- 2 deleted procedure codes
- **D5820** interim partial denture (including retentive/clasping materials, rests, and teeth), maxillary and **D5821** interim partial denture (including retentive/clasping materials, rests, and teeth), mandibular
The requirement to replace an extracted or loss of permanent tooth within 21 days of the extraction or when the tooth was lost is removed. Effective January 1, 2023, the interim partial denture is allowed once per 12 months per arch and limited to once per tooth per lifetime.
- The Addendum to 2022 Procedure Code Guidelines – WellCare by `Ohana Only – New Medicare Advantage Codes will no longer be covered effective 01/01/2023
